Advanced Tickets

These are non-refundable; the tickets can be exchanged prior to departure for a Rail Delivery Group charge of £10.00 plus any difference in fare per ticket. Advanced tickets can be exchanged for the exact same journey for another time or date, no refund will be offered should the new ticket be of lower value; however, any increase in fare must be paid. The exchange / new booking must take place prior to departure of the original ticket.

Should tickets be exchanged please make a new reservation to meet the above restrictions.
